Processing

- The material temperature must be 18 - 25°C.
- The packages should be shaken well for homogenisation before use.
- The mould surfaces must be clean, dry, free of dust and grease before release. Laquer and sealer coatings should be dried resp. cured.
- For cleaning from wax residues we recommend Sika® Reinigungsmittel 5.

Storage

- Minimum shelf life is 12 month under room condition (18 - 25°C), when stored in original un-opened containers.
- Containers must be closed water tight immediately after use and prevented from moisture. The residual material has to be used up as soon as possible.
